IIT Dharwad reserves the right to screen and shortlist candidates by introducing higher benchmarks. Emails will be sent to all shortlisted candidates.

3.	Schedule	Date and Time-slots will be communicated through email. Tentative date of written test and/or interviews: 31st July 2024. Any change in the schedule will be notified on the IIT Dharwad website.
4.	Documents Required	Applicant should have online version of all original certificates including mark sheets (matriculation onwards), experience certificate(s) (if any), monthly emoluments/salary drawn (if any), and all other relevant documents (including one set of self-attested certificate(s)/document(s) and updated Curriculum Vitae).

**General Instructions to the applicants:**

1	Selected candidates shall not have claim on any regular position and shall not be bestowed any of the privileges like Housing, Medical Facility and Other benefits available to regular employees of the Institute.
2	Applicants are advised to ensure, before appearing for the Selection Process, that they possess the minimum essential qualification and experience laid down for the post. Qualification obtained has to be from a recognized University/Institute. Eligibility in terms of age, qualification and experience of a candidate shall be considered as on the date of Selection Process.
3	The number of vacancies indicated in the notification is tentative. IIT Dharwad reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIT Dharwad reserves the right to NOT fill any of the posts advertised.
4	No TA/DA will be paid for attending the Selection Process.
5	In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to <i>modify, withdraw</i> or <i>cancel</i> any communication made to the Applicants.
6	After joining the service of the Institute, the person(s) will have to abide by the Rules, Regulations, Ordinances, Statutes and Act of the Institute applicable from time to time. He/She may be assigned any duty within or outside the Institute depending upon the exigency of the work.
