2.	Selection process	Applications will be initially screened and shortlisted for a test or further shortlisted for an interview. The test/interview will be conducted online. Mere fulfilment of minimum eligibility will not bestow the right for shortlisting. IIT Dharwad reserves the right to screen and shortlist candidates by introducing higher benchmarks. Emails will be sent to all shortlisted candidates.
3.	Schedule	Date and Time-slots will be communicated through email. Tentative date of written test and/or interviews: 18/07/2024. Any change in the schedule will be notified on the IIT Dharwad website.
4.	Documents Required	Applicant should have an online version of all original certificates including mark sheets (matriculation onwards), experience certificate(s), monthly emoluments/salary drawn, and all other relevant documents (including one set of the self-attested certificate(s)/document(s) and updated Curriculum Vitae.

General Instructions to the applicants:

1	Selected candidates shall not have claim on any regular position and shall not be bestowed any of the privileges like Housing, Medical Facility and Other benefits available to regular employees of the Institute.
2	Applicants are advised to ensure, before appearing for the Selection Process, that they possess the minimum essential qualification and experience laid down for the post. Qualification obtained has to be from a recognized University/Institute. Eligibility in terms of age, qualification and experience of a candidate shall be considered as on the date of Selection Process.
